TRINITY PRESBYTERIAN CHURCH Congregational Meeting of January 31, 2021

The congregation met on January 31, 2021, at 11:20 a.m. by Zoom conferencing, as the church is closed due to the Covid pandemic. Moderator Katheryn McGinnis called the meeting to order and opened the meeting with prayer. Charlie May, Clerk of Session, declared a quorum. There were no proposed changes to the agenda. The purpose of the meeting was to elect two elders to fill the office for the class of 2023 to elect three deacons for the class of 2023, to elect a Nominating Committee for the class of 2023, and to present the 2021 budget.

Richard Robinson, chair of the Nominating Committee presented his report. For Session Class of 2023, George Bunch and Ed Sams were nominated to fill the three year terms of ruling elder. There being no further nominations from the floor it was **MSP** to elect these two persons as elders for the term. For the Deacons Class of 2023, Amanda Bell, Glenn Joy, and Marta Narus were nominated for three year terms. This will be Marta's 2nd consecutive three year term. There being no further nominations from the floor, it was **MSP** to elect these three persons as deacons.

Clerk of Session, Charlie May, then presented the Session report for the Class of 2023 Church Nominating Committee. The names of Jane Devette-Gomez, Lenore Spalaris, and Joanne Clever were put before the congregation. Richard Robinson has agreed to serve as chairperson of the committee for 2021. There being no nominations from the floor, the congregation **MSP** to elect Jane, Lenore, and Joanne to fill the Class of 2023 Nominating Committee.

The 2021 budget was presented by Chad Bell who answered questions from the congregation.

Since there was no further business, the Moderator asked for a motion to adjourn. **MSP** Katheryn closed the meeting with prayer at 12:40 p.m.

Pastor's 2021 Annual Report

What a year 2021 was! 2021 marks my first full calendar year as your pastor.

We started off 2021 still worshipping online. Ellen, Chuck, the Bell family, and myself were in the sanctuary while you all joined us from home on zoom each Sunday morning. We continued this model through Lent, until Easter Sunday where we had our first in person worship service since March of 2020. After Easter we began worshipping in the sanctuary in person, and while it took a while to find our rhythm and navigate how to best do in person worship safely, it is wonderful to have been worshipping in person since June. My continued thanks to the worship team for their tremendous help navigating all the transitions with grace and support.

The first Sunday in person in the sanctuary was certainly a special one for me. I remember clearly the nerves and joy preaching from the pulpit to our sanctuary full of people for the first time since moving to Santa Cruz. I am grateful that I have been able to continue to do so since that first Sunday. Thank you to you all for wearing masks and following our Covid safety measures so we can continue to worship in person!

Like worship, all other programs of the church faced many transitions this past year. Committees went from meeting on zoom, to meeting in person, to sometimes going back to zoom. Fellowship events had to adapt and change to meet everyone's comfort levels. If anything 2021 has taught us, it has taught us to be flexible! As a result of this flexibility, we adapted our newsletter, Steeple Talk, from a monthly printed newsletter to a weekly email newsletter. This has allowed all information about the life of the church to relayed more quickly and accurately. Whether in person or on zoom, the life of the church has endured.

This past year I was fortunate enough to lead three different Bible studies: our Lenten Bible study, our Advent Bible study, and our continued Thursday afternoon Bible study on Jeremiah. I have enjoyed our thoughtful and critical conversations at all of them. We have learned much from the material and each other!

I was also honored and grateful to lead Jeanne and David Baker's granddaughter Melissa Macy's memorial service. It was a beautiful and simple memorial held outside on the front lawn. Melissa's ashes were spread in the Memorial Garden and a Sweet Pea plant was planted in her honor.

In addition to my pastoral and worship duties, in 2021 I was part of several different ministries. I joined the board of the Association of Faith Communities, an organization that Trinity has been part of since its beginning. We have gone back to hosting the rotating shelter on the 2nd and 3rd Wednesday of each month. I joined our presbytery's Committee on Representation and Empowerment (CORE) and helped facilitate the presbytery Lenten study on the roots of whiteness in the United States and the church. I also continued work with our new Urban Works ministry in partnership with Theresa Nelson, Evan Bondonno, and Rev. Ryan Althaus. We hosted many events throughout the

year, and I was grateful to see Trinity folks at all of them! I continue to be part of all of these wonderful ministries in 2022.

During my first full calendar year as your pastor, I have learned a great deal about the life and dedication of this church. I have enjoyed continuing to get to know you all, hearing more about your stories, and seeing first hand the love and gifts you each bring to this community. Whether it was on Sunday morning, on a church hike, at Bible studies, at happy hour, at the all church retreat, or any moments of fellowship in between, I am grateful for all that you have taught me. I look forward to deepening these relationships in 2022, and seeing where the Holy Spirit moves us next.

Administration Committee - 2021 Annual Report

The Administration Committee met twice in 2021. The rest of the year our work was accomplished via emails.

Chuck Cobery continues to monitor the security camera around the property. There has been a significance reduction in the number of incidents. Mega thanks to Chuck's efforts.

Session Elder Ed Sams did a very thorough audit for us. He recommended the following: "I, Ed Sams, also believe the following recommendations will benefit the organization going forward and suggest to Session that these be put into practice in our organization."

- 1. Church deeds need to be located. They probably are in the safe in the janitor's closet, but Jana and I could not find them. Here is Bob Scott's input: I've searched for the church's property deeds, and I'm convinced that we don't have any copies at the church. Somewhere is a report prepared by a friend of mine who enjoys doing historical property research. He's a retired title company employee. He dug out the recording information on our properties and furnished copies of the deeds. I don't know where his work is now, but I will dig into it for the next audit.
- 2. We should invest in a fire-proof box to put all the deeds, notes, minutes, etc. Here is Bob Scott's information: The file cabinet in the janitor's closet is "fire resistant" not "fire proof". In the past we've kept the official minutes and membership records there.
- 3. Personnel files should not be left in the open by the door to the office, but should be placed in a private but accessible place.
- 4. Emily Duffus should have a title that describes all the responsibility she has and all the work she does. Some cursory research suggests that churches use titles like Bursar or Procurator or even Chief Elder.
- 5. At each annual church meeting the Treasurer and the Bursar should be recognized for the work they do and for what that work means and entails. We should do this for three reasons: (1) they deserve recognition for their constant behind-the-scenes work, (2) the members and congregation should be aware how their pledges and donations are handled, (3) each year's recognition might inspire some members to take on these responsibilities when these posts become available.

Music - 2021 Annual Report

Despite services being solely virtual from January through May 2021, music was still an integral part of every service. Hymns were accompanied by Nicki from her home during Zoom services and anthems were performed the same way, either live by her or with prerecorded music videos which were also done by her.

Easter Sunday was a special treat; we had our first in-person service in over a year (held outside to minimize risk) and the anthem was sung by a virtual choir that included present and past members as well as a few friends. The postlude that day was performed live by Richard Robinson and Nicki as they were accompanied by a prerecorded rhythm section; technology and ProTools (a professional-level recording software program) allowed a drummer in Antioch, CA and a bass player in New Orleans to play along with us.

In-person services, as well as the choir, resumed Memorial Day Weekend. This was possible because every choir member was vaccinated and agreed to wear specially designed singer's masks. The masks were made for us by the Sweet Peas using a pattern Nicki found online.

The Christmas Cantata took a slightly different format this year. Instead of the usual packaged cantata consisting of songs and a script, we instead sang the choir's favorite Christmas carols and songs, adding a bit of the history behind each one and relevant Bible passages.

Guest musicians appeared both virtually and in person, including Richard Robinson, Elizabeth Bunch and her daughter-in-law Carol, Hunter Bauman, and the aforementioned drummer and bassist, Stewart Burr and Antony Bianchini, respectively.

A performing opportunity was offered to, and gratefully accepted by, the Mueller Scholarship recipients of the Santa Cruz Youth Symphony. A young violinist named Pakal was our first performer and we look forward to more from the SCYS Mueller Scholarship recipients over the coming year.

Because of the unexpectedly long hiatus from in-person services, the choir did not take their usual several weeks off during the summer. Instead, they took two weeks off in late October/early November before gearing up for the Christmas season.

We gained three part-time members for the Christmas Cantata and I hope they will become full-time this coming year. I am especially in need of tenors and basses. (Another soprano or two are certainly welcome as well.)

We thank the Trinity church community for their continued support of our music program during these uncertain times.

Trinity continues its involvement with Santa Cruz al Salvador with two members serving on its board of directors. The organization was unable to send its annual delegation to El Salvador in 2021 due to Covid restrictions. Currently the main focus of the organization is to support education through primary, secondary, and college scholarships, and to build compost latrines in remote rural areas. Santa Cruz al Salvador has also found opportunities to help El Salvadorans in special circumstances needing assistance.

Trinity continues to host participants in the Faith Community Shelter. This program had been limited to two churches during the pandemic, but in November Trinity began providing dinners and hosting overnight shelter again on the second and third Wednesdays in Fellowship Hall.

Trinity has a long history of strong mission and intends to build on that reputation in 2022. Trinity members are encouraged to recommend mission efforts to the mission committee, or even better join us as a committee member!

Stewardship Committee - 2021 Annual Report

The annual Pledge Drive ended in December 2021. Approximately 38 pledges were received by the Church, for a total of approximately \$163,000.00, which is down from \$170,000 from previous years, most likely due to the loss of some pledgers that either moved or passed away. The generosity of the congregation, particularly in a year that has seen a minimal personal interaction among church members due to COVID-19, was better than expected, and we are very blessed here at Trinity. Thank-you notes were sent to the Pledgers by Committee Member **Emily Duffus** as a gesture of appreciation and respect.

Worship and Christian Education - 2021 Annual Report

The mission of the Worship and Christian Education Committee is to plan the worship experiences of our church and oversee the educational opportunities for the children, youth and adults of Trinity Presbyterian Church, Santa Cruz, California.

2021 was a year of creativity in our attempts to create meaningful worship opportunities in the middle of a world-wide pandemic. In January, Zoom was our main method of interaction. Zoom worship, Zoom fellowship, Zoom meetings and Zoom Bible Studies filled our calendar.

As the year moved along, we worked on our creativity. We prepared a recorded Ash Wednesday service and Katheryn provided the opportunity to receive "covid-safe drive-by ashes." Holy week was a variety of activities with a Zoom Palm Sunday service and we waved branches together on Zoom. We pre-recorded our Maundy Thursday service and took communion in our homes. On Good Friday, we were invited to join several local churches for a Stations of the Cross march through downtown Santa Cruz. Easter services were described as "So, so good!" and "Miraculous!" It was our first time worshipping in person in many months! It was a beautiful Sunny day and we met outside on the Poplar Street lawn. We had two services and reservations were encouraged. We all wore masks, temperatures were recorded and lots of effort went into social distancing. But it was so wonderful to be together. We recorded the service, streamed it to Vimeo and our website to allow at-home viewing for those unable to gather in person. We are continuing this practice to the present and feel it is important to remain connected as a community.

Our first in-church worship service in more than a year was May 16. We observed the safe practices recommended by Santa Cruz County. Only the choir sang, and they used specially designed "singer's masks" created by Nicki.

Other special worship activities for our year included Pentecost, a colorful and bright day with streamers, balloons and flowers. Acts 2:1-4 was read aloud in many different languages and the Lord's Prayer recited in a multitude of voices. World Communion Sunday was another creative day of worship. A beautiful presentation of breads from around the world was created by Marta Narus and Jeff Lawton. All Saints Day recognized those in our church family who have died in the past year and chimes rang with each name read. On Veteran's Day weekend, Chuck Cobery spoke in a tribute to veterans and armed service members. Our traditional "Christmas Cantata Sunday" was held on December 19. The choir shared Christmas music favorites of the past, present and future. A Longest Night service was held on December 21, a service in recognition of the difficulties and grief some people have during the holiday season. The Christmas Eve Service was our traditional and beautiful candlelight service with Lessons and Carols.

Adult Education

Our <u>Lenten Study</u> was a five week Zoom study titled "Seeking the Intercultural Church." The leadership was shared. A similar four-week Advent Study was held in person. It was titled "Peace, Justice, Joy and Salvation." It was well attended and delightful to meet together again.

Our first of two Faith, Ethics and Social Concern Forums was on Zoom, titled "Racism in Church and Society: Awareness and Action." Katheryn McGinnis spoke of her family history in North Carolina and the Presbyterian connections. Glenn Joy told of his experiences with racism and the church in Texas and Father Nat Johnson spoke of his life growing up black and becoming an Orthodox priest in the San Lorenzo Valley. Our second forum was held in October, and titled "Health Care in America: Quality, Accessibility, Equity and Affordability." We had two excellent speakers, one from the Santa Cruz County Health Office and our own Mayre Vincent, a nurse and hospital case manager at Kaiser. We had a very disappointing turn-out for this forum and look to do better next time. Special thanks to Darrell Yeaney for his leadership and work on these forums.

We have two Sunday study groups, the <u>Lectionary Study Group</u> led by Truett Bobo and friends. They study the lectionary selections for each week. "The Niners" now called "<u>The Nooners</u>" meet for book discussion on a variety of topics. These were both Zoom studies and have now returned to in-person gatherings. A mid-week study on the book of Jeremiah, alongside Brueggemann's book, a <u>Commentary on Jeremiah</u> continued to meet for most of the year.

All-Church Retreat

Our All-Church Retreat_at Missions Springs was well attended with 30-35 in attendance. A great time was had by all even with all the rain! Thank you, George Bunch, for your behind-the-scenes organization.

Youth

Our youth are still not meeting regularly, but are in church nearly every Sunday, working the cameras, the computer, the sound board and are always willing lectors.

There are so many people to recognize for their work in making these challenging worship and education opportunities successful. Katheryn McGinnis, we are so glad you are on our Trinity team! Our year with you has been a delight! Nicki Kerns and choir, you have done an amazing job providing creative musical offerings for each worship service. Some of those pieces have been works of art! Marta Narus, your attention to detail has been critical in making worship run smoothly. Special thanks to the AV Worship team; Chuck Cobery, Chad Bell, Justin Bell, Rosie Bell, and Katheryn McGinnis. We appreciate all you do!
